## CITY OF DONNELLY ORDINANCE NUMBER

AN ORDINANCE OF THE CITY OF DONNELLY, IDAHO, AMENDING ORDINANCE NO. 233, THE APPROPRIATIONS ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2016, APPROPRIATING ADDITIONAL REVENUE TO BE RECEIVED BY THE CITY OF DONNELLY, IDAHO IN THE FISCAL YEAR FOR LOCAL OPTION TAX REVENUE; PROVIDING THE REPEAL OF AN ORDINANCE PROVISION AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Mayor and City Council of the City of Donnelly,

SECTION 1: That Ordinance No. 233, the appropriations ordinance for the City of Idaho for the fiscal year commencing October 1, 2016, be, and the same is hereby repealed, as follows:

That the additional amount \$41,900 be appropriated out of the revenue from the local option tax fund to be used on authorized capital improvements.

SECTION 2: All ordinances and parts of ordinances in conflict with this ordinance be repealed.

SECTION 3. This ordinance shall take effect and be in full force upon its publication in one issue of the Star News, the official newspaper of the City of Donnelly.
