ORDINANCE NO. 151

AN ORDINANCE OF THE CITY OF DONNELLY, IDAHO, DESIGNATING THE "LONG VALLEY ADVOCATE" OF CASCADE, IDAHO, AS THE OFFICIAL NEWSPAPER FOR THE CITY OF DONNELLY, TOGETHER WITH AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DONNELLY, IDAHO, AS FOLLOWS:

Section 1.: Pursuant to Idaho Code, section 50-213, the "Long Valley Advocate", Cascade, Idaho, is the official newspaper of the City of Donnelly. Publication of official notices, calls for bids, ordinances and other matters in this newspaper of general circulation shall constitute legal publication within the requirements of Federal codes, State statutes and local ordinances.

Section 2.: Ordinance No. 150 is hereby repealed.

Section 3.: This ordinance shall be in full force and effect from and after its adoption upon publication in the City's official newspaper of record.

ORDINANCE NO. 152

AN ORDINANCE RELATING TO PLANNING AND ZONING; AMENDING SECTION 2 OF ORDINANCE NO. 82 OF THE CITY OF DONNELLY, IDAHO, INCREASING THE NUMBER OF MEMBERS OF THE DONNELLY PLANNING COMMISSION AND PROVIDING THAT 2 MEMBERS MAY BE APPOINTED FROM THE DONNELLY AREA OF CITY IMPACT DESIGNATED BY THE BOUNDARIES OF THE DONNELLY RURAL FIRE DISTRICT.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF DONNELLY, IDAHO:

Section 1. That Section 2 of ordinance No. 82 of the City of Donnelly, Idaho, passed and approved the 19th day of October, 1981 and as amended by Ordinance No. 117 on April 16, 1990 is hereby further amended to read as follows:

Section 2. QUALIFICATIONS; TERM OF OFFICE: Said Planning Commission shall consist of ~~five (5)~~ seven (7) members to be appointed by the Mayor without respect to political affiliation. All members shall be qualified electors of the City, or within the designated area, and county residents for a minimum of two (2) years prior, except that two (2) members may be appointed from within the Donnelly Area of City Impact designated by the boundaries of the Donnelly Rural Fire District. At the first meeting of the Planning Commission the members shall choose their term of office by lot as follows: ~~two (2)~~ three (3) for three (3) years; two (2) for four (4) years, and ~~one (1)~~ two (2) for five (5) years, and shall immediately thereafter notify the Mayor and council of such terms. Thereafter their successors shall be appointed for, and shall hold office for a term of six (6) years. Members may be removed by a majority vote of the Council. In the event of the death, resignation or any vacancy in said Commission, the Mayor is hereby authorized and empowered to fill such vacancy by appointment for the unexpired term of such member or members.
